# Price Guide

### What we charge for

When you receive our services, we bill you according to the NDIS price guide in four areas:

- 1. Direct services** (face to face) – which includes:
  - Initial client meeting(s) – where we get to know the client and family, set goals, and start initial assessments
  - Home/community sessions – providing supports either at home, at school, or in the community
  - Clinic sessions – providing supports to our clients at our clinic
  - Telehealth – our clinicians are also available to provide therapy services and consultations over the phone or online (via Google Meet)
- 2. Indirect services** (non-face to face) – which includes:
  - Clinical notes – as part of our clinical services it is required that there is a clear and detailed record of each session
  - Review of documentation – if you request, or it is necessary, for us to review documents related to the client such as previous therapy reports, medical reports, diagnostic reports, school reports and other health related reports.
  - Completing NDIS reports and client requested reports
  - Communication with other stakeholders – when our clinical expertise is required to collaborate with other service providers or to provide consultation to you, your family or supports. This may include phone calls, video calls or emails
  - Therapy programs – programs developed and written by our clinicians and for use at home, for teachers/EAs, therapy assistants or support workers
  - Resource development – if you require any additional resources to be created for use at home, school or in the community we are able to do this for you. This may include worksheets, school activities or communication aids (This must always be approved by the client each time)
- 3. Travel time** to visit you in the community, at your home, or at your child's school
  - We do our best to ensure that when we travel to see you, particularly out to the regions, that we book other clients in the same region in for the same day, so that the travel costs can be shared evenly between clients
  - We DO NOT charge for the kilometres traveled on top of charging for our time
- 4. Late cancellations** – you will be charged 90% of the scheduled fee if the appointment is cancelled after 3pm the business day before, or if the appointment is missed.
